## Q: AM I ELIGIBLE FOR THE VACCINE?

A: YES! If you are an NBRC client who is 16 years or older, a direct service provider, or a family member living with a client with certain health conditions, you are eligible for the vaccine. Click <u>Here</u> for criteria for a family member.

### Q: IS THE VACCINE SAFE FOR ME?

A: If you have concerns about the vaccine, please reach out to your primary care physician to answer your questions.

## Q: WHAT IF I HAVE A HARD TIME WEARING A MASK?

A: If you have a hard time wearing a mask, a drive thru vaccination site may be the best option. Confirm with the site that they will allow you to receive the vaccine if you are not wearing a mask.

# Q: WHAT IF I RECEIVED THE FIRST DOSE BUT MISSED OR WAS UNABLE TO SCHEDULE MY SECOND DOSE?

A: Email <u>vaccine@nbrc.net</u> for assistance scheduling your second dose. If you wait too long, you may have to receive your first dose again.

#### Q: HOW DO I REGISTER FOR THE VACCINE?

A: There are several ways to register for the vaccine. Below are some options available for NBRC clients or visit the NBRC <u>website</u> for the most current dates and vaccination sites for NBRC clients.

# Q: HOW DO I GET A COPY OF THE LETTER FROM NBRC CONFIRMING MY ELIGIBILITY FOR THE VACCINE?

A: If you are an NBRC client and did not receive a copy of the letter sent by NBRC confirming your eligibility for the vaccine, reach out to your Service Coordinator or send an email to <a href="mailto-vaccine@nbrc.net">vaccine@nbrc.net</a> with your name and mailing address, requesting a copy of the letter.
